The fee for an alarm registration/renewal is set forth below and shall be paid by the alarm user. No refund of a registration/renewal fee will be made. For registered Burglar/Robbery alarm system s with securitycameras installed at alarm location are facing the City's right of way has first to sixth false alarm has no fine but warning notice will be issued, fine for seventh false a larm is \$50.00, eighth false alarm is \$100.00, ninth false alarm and above is \$200.00 each. For other Burglar/Robbery alarm systems first to third false alarm has no fine but warni ng notice will be issued, fine forforth false alarm is \$50.00, fifth false alarm is \$100.00, sixth false alarm and above is \$200.00 each.
